STANFORD LAW SCHOOL

The Class of 2005 today joins a storied history of Stanford law graduates stretching back over a century to 1895, when the fledgling Stanford University conferred the degree of Bachelor of Arts in Law upon four seniors. The first graduate degree—a Master of Arts in Law—was introduced the next year, and in 1901, the equivalent of today’s professional Doctor of Jurisprudence degree (JD) was inaugurated as the Bachelor of Laws (LLB). Stanford Law School has since developed the degrees of Doctor of the Science of Law (JSD), Master of Legal Studies (MLS), Master of the Science of Law (JSM), Master of Laws (LLM), as well as a joint degree (JD/MBA) with the Graduate School of Business.

Stanford’s tradition of legal excellence began in 1893, when the university engaged its first two law professors. One was Benjamin Harrison, former president of the United States, who delivered a landmark series of lectures on the Constitution. The other was Nathan Abbott, head of the nascent law program. Abbott assembled around him a small faculty, to which he imparted a standard of rigor and excellence that endures to this day. In honor of Stanford Law School’s first leader, the student with the highest academic standing in each year’s graduating class is designated the Nathan Abbott Scholar.

Following Abbott’s departure in 1907, the deanship was held successively by Frederic Woodward, Charles Huston, and, from 1922 to 1945, Marion Rice Kirkwood. During Dean Kirkwood’s tenure, the law school saw the successful introduction of a new moot court program, the institution of the Stanford Law Association—forerunner of today’s alumni law societies—and the first directory of Stanford law alumni. Carl Bernhardt Spaeth became dean in 1946, and under his leadership, extending until 1962, the school assumed its modern form. During the deanship of Bayless Manning (1964–71), Stanford expanded its role of national leadership in legal education.

Dean Thomas Ehrlich (1971–76) led the successful effort to fund and build Crown Quadrangle, a complex of buildings designed specifically for the study of law and dedicated by President Gerald Ford on September 26, 1975. Stanford Law School consolidated its position as one of the nation’s top law schools during the deanship of Charles J. Meyers (1976–81), who led new initiatives in law, economics, and business.

Dean John Hart Ely (1982–87) promoted public interest programs for students, creating the nation’s first loan forgiveness program for graduates who chose public interest jobs and starting a legal aid clinic in East Palo Alto. Under the leadership of its tenth dean, Paul Brest (1987–99), the law school strengthened the connections between law, business, and public policy and conducted a highly successful fundraising campaign intended to secure the future of the school.

Dean Kathleen M. Sullivan (1999–2004) spearheaded a thorough, technologically sophisticated renovation of the law school physical plant and secured the residential comfort of future students by raising the largest individual gift ever to an American law school to build a new residence complex adjacent to the school. She also introduced a new LLM program and reinvigorated clinical education at the law school.

Larry D. Kramer was installed as the law school’s twelfth dean in September, the fourth consecutive constitutional scholar to serve in the role of Stanford law dean. Mr. Kramer has already recruited one of the nation’s leading clinical professors to direct the school’s clinical program, and has proposed a number of new initiatives geared toward enabling Stanford law students to take full advantage of all of the resources available at Stanford University.

There have been and will be many changes at Stanford Law School; but the basic mission has not changed since Abbott’s day: dedication to the highest standards of excellence in legal scholarship and to the training of lawyers equipped diligently, imaginatively, and honorably to serve their clients, lead our shared profession, and solve the problems of our nation and our world.
