

Warm congratulations to the Class of 2002, which today joins an honor roll of Stanford law graduates stretching back over a century to 1895, when the fledgling Stanford University conferred the degree of Bachelor of Arts in Law upon four seniors. The first graduate degree—a Master of Arts in Law—was introduced the next year, and in 1901, the equivalent of today's professional Doctor of Jurisprudence degree (JD) was inaugurated as the Bachelor of Laws (LLB). Stanford Law School has since developed the degrees of Doctor of the Science of Law (JSD), Master of Legal Studies (MLS), and Master of the Science of Law (JSM), as well as a joint degree (JD/MBA) with the Graduate School of Business. In the autumn of 2002, the School will enroll its first class of Master of Laws (LLM) candidates from a variety of nations abroad.

Stanford's tradition of legal excellence began in 1893, when the University engaged its first two law professors. One was Benjamin Harrison, former President of the United States, who delivered a landmark series of lectures on the Constitution. The other was Nathan Abbott, head of the nascent law program. Abbott assembled around him a small faculty, to which he imparted a standard of rigor and excellence that endures to this day. In honor of Stanford Law School's first leader, the student with the highest academic standing in each year's graduating class is designated the Nathan Abbott Scholar.

Following Abbott's departure in 1907, the deanship was held successively by Frederic Woodward, Charles Huston, and, from 1922 to 1945, Marion Rice Kirkwood. Carl Bernhardt Spaeth became dean in 1946, and under his leadership, extending until 1962, the School assumed its modern form. During the deanship of Bayless Manning (1964–71), Stanford expanded its role of national leadership in legal education.

Further advances were made during the deanship of Thomas Ehrlich (1971–76), who led the successful effort to fund and build modern quarters for the School. Crown Quadrangle, a complex of buildings designed specifically for the study of law, was dedicated on September 26, 1975. Stanford Law School consolidated its position as one of the nation's top law schools during the deanship of Charles J. Meyers (1976–81), who led new initiatives in the areas of business law and law and economics.

The tenure of Dean John Hart Ely (1982–87) saw continued innovation, with loan repayment assistance programs for students choosing public interest employment and the development of clinical learning opportunities. Under the leadership of its tenth dean, Paul Brest (1987–99), the Law School expanded its offerings in law and business; environmental law; dispute resolution; law, science, and technology; and public policy. The generosity of the School's alumni and friends during the Campaign for Stanford Law School (1995–99) enabled the retention and recruitment of our current exceptional faculty.

There have been, and will be, many changes at Stanford Law School. We have recently brought our beautiful new classrooms into the twenty-first century, and are continuing to bring our teaching and research into the twenty-first century through the use of new technologies. In an era of globalization that has changed the way that law and business are practiced, our focus is more international than ever before. And we continue to pioneer new methods of simulated problem solving and clinical teaching that will prepare our students to exercise wise practical judgment and leadership when they graduate. But our ultimate goals remain unchanged since Abbott's day: dedication to the highest standards of excellence in legal scholarship and to the training of lawyers equipped diligently, imaginatively, and honorably to serve their clients, our shared profession, and the needs of our nation and our world.
