1 **TO RESPONDENT COUNTY OF MARIN:**

2 Judgment having been entered in this action ordering that a writ of mandate issue from this  
3 Court:

4 **RESPONDENT COUNTY OF MARIN IS HEREBY COMMANDED:**

5 (1) To set aside the August 20, 2019, approval of the 2007 Marin Countrywide Plan with  
6 Respect to the Application of the 2007 Marin Countrywide Plan's Policies Governing Biological and  
7 Wetland Resources in San Geronimo Valley ("Project") and certification of the accompanying Final  
8 Supplemental Environmental Impact Report to the Marin Countrywide Plan Final Environmental  
9 Impact Report With a Focus on Potential Cumulative Impacts to Salmonoids in the San Geronimo  
10 Valley ("SEIR").

11 (2) To file an initial return to this writ within 60 days, reporting to the Court the steps and  
12 schedule the County proposes to take to comply with the April 2, 2015 writ of mandate, consistent  
13 with this Court's April 8, 2021 order that the County take "reasonably expeditious action".

14 (3) To submit to the Court, every three months until the writ is discharged, a report  
15 updating the Court on the County's compliance with the steps and schedule outlined in its initial  
16 return.

17 (4) Pursuant to Public Resources Code section 21168.9(a)(2), to desist and refrain from  
18 approving any development authorized by the Project in the San Geronimo Valley until the County  
19 of Marin has taken all actions to comply with this writ.

20 (5) To proceed in good faith and without delay with respect to the filing of the final return  
21 and the corrective action taken pursuant to this writ.
