Dear Ms. Sanders,

Thank you for sending this spreadsheet (attached), which appears to contain information on cases pertaining to the Lanterman Act filed with the Office of Administrative Hearings from 1/1/1018 through 7/31/2019. I am cc'ing Joy Rosenquist and Tom Blythe on this e-mail, since I have been in touch with both of them this morning about this request and want to make sure everyone is on the same page.

My understanding is that when combined with the information you produced in response to our prior PRA request dated January 12, 2018 (which I included as an attachment to the PRA request from Aug. 8th), this information represents the best and most complete information you have on cases pertaining to the Lanterman Act filed with the Office of Administrative Hearings from July 1999 through August 8, 2019 pursuant to sections 4714(b) and 4712.5(d) of the Lanterman Act. Please let me know if my understanding is incomplete or incorrect in any way.

Secondly, I would be grateful if you could clarify whether each of the following six outcomes of cases filed with the Office of Administrative hearings *always*, *sometimes*, or *never* result in published OAH opinions: (1) Denied; (2) Granted; (3) Split; (4) Administratively closed; (5) Dismissed; and (6) Withdrawn.
