Since the creation of the *pro-bono* department, in September 2021, our firm has been able to handle 15 new public interest litigation cases free of charge.
- Represented a group of medical professionals and first responders in an *amparo* claim against the State's decision not to provide COVID-19 vaccines and medical equipment for private practitioners.
- Successfully represented a construction company in a litigation between shareholders that kept frozen the construction of a development valued at more than USD 40 million. After obtaining a series of injunctions, the dispute ended in a favorable negotiation for the client, allowing the real estate project to continue.

Junior Associate January 2019 – August 2021

- Filed over 150 lawsuits against the cancellation of Mexico's New International Airport. My team and I handled 15 *amparo* claims and obtained injunctive relief that froze the cancellation for several months.
- Represented a group of breast cancer patients which were affected by the cancellation of Mexico's *Seguro Popular* (public health insurance program). The District Court ordered the Federal Authorities to provide immediate medical assistance and reinstate the *Seguro Popular* benefits.
- Represented a consortium of companies in a dispute with the Government of Mexico City, regarding a series of contracts for the provision of services within the world's largest wholesale market and whose value exceeds USD 120 million.
- Filed an *amparo* claim on behalf of person with down-syndrome who was denied anti-depressant and anti-psychotic medication by health authorities. The Judge ordered immediate delivery of the medication and issued a novel "*easy-to-read*" judgment for plaintiff.
